Notification

As per this Institute Notification no. IIITS/ACAD/2020/11 dated 30.6.2020 Institute was closed up to 31.07.2020 in public interest as a preventive measure due to COVID-19 pandemic. Further in pursuance of the letter no. 16-6/2020-U1A dated 30th June, 2020 of Ministry of Human Resource Development, Department of Higher Education, Govt. of India, New Delhi, it is hereby notified for the information and compliance of all concerned that: -

1. Summer vacation is over on 30.6.2020.
2. Evaluation of the students to be carried out as per the Examination Notification issued by the Institute vide Notification no IIIT/2020/56 dated 25.6.2020. Faculty members and the concerned staff will ensure the timely completion of the examination work.
3. In order to ensure safety of Faculty members of the Institute, the following precautions shall be taken.
 - (i) Faculty members of the Institute are permitted and advised to work from home till 31.7.2020.
 - (ii) Faculty members should utilize this period for various academic activities such as:-
 - (a) Development of online contents, online teaching & online evaluation and video lectures/lecture notes etc.
 - (b) Development of lesson plan, instructional material for the courses to be offered during the next academic semester/year.
 - (c) The faculty members will continue to interact with students through online/distance mode for special lectures/inculcating value added knowledge.

4. The period shall be counted as being on duty for all the Faculty members including contract teachers whose contract are valid upto 31.7.2020. In case if the contract of faculty members is over on 30.6.2020 in that event the validity of on duty period for the month of July, 2020 is counted from the date of extension of contract/joining date on new contract to 31.7.2020.
5. The office staff related to examination and other important and essential work will attend the office on need basis and will ensure that no urgent work is left unattended. Such staff shall operate with all precautionary measures as mentioned in the guidelines issued by MHA/MHFW Govt. of India from time to time.
6. In case of any exigency, any Faculty members may attend or be asked to attend the Institute with all precautionary measures as mentioned in the guidelines issued by MHA/MHFW, Govt. of India from time to time.
