Reporting Schedule for newly admitted B. Tech. candidates through JoSAA/CSAB-2023 counselling process for the Academic Year 2023-24

The candidates who have been provisionally allotted a seat in the B. Tech. programmes at IIIT Sonepat through JoSAA/CSAB-2023 counselling process for current Academic Year 2023-24 are required to report ONLINE during 14th -21st August 2023 and follow the process as explained below:

- (1) The candidates who are required to pay Balance Institute Fee, if applicable as per Annexure-B1, B2 and B3 must pay the same through SBI Collect link provided by the Institute in this notification. The link will be active from 10.00 am on 14.08.2023 until 05.00 pm on 21.08.2023.
- (2) Thereafter, the candidates are required to fill the Google Form (link will be available on the Institute website before 14.08.2023) for online reporting wherein the payment receipt of Balance Institute Fee, if applicable, and also the relevant documents as per Annexure-A are to be submitted. The link for Google Form will also be activated for this purpose from 10.00 am on 14.08.2023 and remain active till 5.00 pm on 21.08.2023.
- (3) The candidates are mandatorily required to submit the duly filled and signed undertaking forms as per Annexure-D regarding the genuineness and validity of the documents as part of Annexure-A.
- (4) The provisional Roll No. will be issued to those candidates only who have completed all the above three steps.
- (5) The admission will be provisional till the documents are physically verified at the Institute. Further, the dates for the same will be notified on Institute website in due course of time.
- (6) The candidate who does not report after payment of Balance Institute Fee (if applicable as per Annexures- B1, B2 & B3 during online reporting as per above schedule), will lose the allotted seat for which only he/she will be responsible. It is responsibility of the candidate to complete all the admission formalities in the finally allotted institute.
- (7) The physical reporting and allotment of hostel will be made on August 22,2023 and August 23, 2023 after their arrival.

- (8) The orientation programme for 1st semester of B. Tech. programmes will be on August 24, 2023 (Tentative) and the classes commence from August 25, 2023 (Tentative) in offline mode. The schedule & time table for orientation programme & classes will be available on the Institute website in due course of time.
- (9) The Institute fee refund rules, as mentioned in Annexure-B4, shall be applicable after admission if any candidate withdraws his/her admission.
- (10) The candidates are required to visit the Institute website (www.iiitsonepat.ac.in) regularly for latest updates.

- VIII. Address Proof Document, if address is different from Aadhaar Card I.e. Driving License, Passport, Electricity Bill, Ration Card, Election Card(EPIC), Passport etc. (Rent Agreement or address certified by the Employer on letter pad is also considered valid address proof).
- IX. Migration Certificate and Character Certificate (from the Institute/School last attended) [These documents are not mandatory documents for online reporting, however these will be required in original at the time of physical reporting from all candidates].
- X. Medical Fitness Certificate issued by the Registered Medical Practitioner (RMP)/MBBS on JoSAA/ CSAB-2023 format.
- XI. Undertaking duly filled and signed on the prescribed format as per Annexure-D.
- XII. Cancelled Cheque or Pass Book regarding bank account details (Bank Account must be in the name of Candidate for all types of transactions in the Institute including refund of fee, disbursement of scholarship etc.).
- XIII. Anti-Ragging Certificate duly filled and signed on the prescribed format as per Annexure-E.
- XIV. Gap Year Certificate should be on Rs. 10/- to Rs. 50/- Non-Judicial Stamp Paper (Affidavit) and attested by the Notary.

The candidates are required to upload passport size color photograph having light background and in light color dress and also the image of signature on plain paper using black pen.


