Refund Fee Policy for IIIT Sonepat

Refund Rule for 1st Semester

1. If a student allotted a seat at IIIT Sonepat fails to report to the Institute as per the JoSAA/CSAB schedule as well as notification issued by the Institute, and the Institute has received the fee from the admitting authority, The entire fee shall be forfeited, and the student shall not be eligible for any refund.
2. If a student reports to IIIT Sonepat but fails to complete Institute registration as per the notified schedule by the Institute, and the Institute has received the fee, The entire fee shall be forfeited, and No refund shall be admissible.
3. If a student submits his/her request for admission cancellation within 30 days of the last date of reporting (as per notification issued by the Institute), the entire “Tuition Fees” shall be forfeited. However, the student shall receive refund of full “Other Fees” including the Caution Money after deduction of Rs. 5,000/- (Rupees Five Thousand Only) towards Processing Charges.
4. If the cancellation request is submitted after 30 days from the last date of reporting (as per notification issued by the Institute), the entire “Tuition Fees” as well as full “Other Fees” shall be forfeited, and the student shall not be eligible for any refund except the Caution Money.

Refund Rule for 2nd Semester Onward

1. If a student submits his/her request for admission cancellation within 7 Days of the last date of fee submission (as per notification issued by the Institute) for the semester, 25% of the “Tuition Fees” for the concerned semester shall stand forfeited. The balance 75% of the “Tuition Fees” shall be refunded after completion of the Admission Cancellation Process. In such case, 100% of the “Other Fees” shall be forfeited and no refund on that account shall be done except Caution Money.
2. If a student submits his/her request for admission cancellation after 7 Days of the last date of fee submission (as per notification issued by the Institute) for the concerned semester, 100% of the “Tuition Fees” as well as “Other Fees” for the semester shall be forfeited and the student shall not be eligible for any refund except Caution Money.
3. If a Student Submit his/her request for admission cancellation before last date of fee submission (as per notification issued by the Institute) of the concerned semester, he/she shall be permitted to collect original migration/Transfer Certificate submitted at the time of admission without paying any fee for the semester.

OTHER TERMS GOVERNING CANCELLATION & REFUND POLICY

1. All refunds, including Caution Money, shall be subject to deductions for damage or loss to Institute property (laboratory equipment, IT assets, library materials, hostel assets, furniture, etc.) attributable to the student.
2. If admission is cancelled by the Institute due to disciplinary action, violation of Anti-Ragging Regulations, breach of Code of Conduct, or any misconduct, all Fees shall be forfeited, Only Caution Money shall be refundable after adjustment of dues.
3. The decision of the Director, IIIT Sonapat, shall be final in all matters relating to admission cancellation and fee refund, including cases not explicitly covered in this policy.
4. The Institute reserves the right to amend or modify this policy in the interest of the Institute. Any revision shall be notified through the Institute website.
5. In case of any legal dispute relating to admission cancellation or fee refund, jurisdiction shall lie exclusively at Sonapat, Haryana (India).
